#### **Background**

Using relational data-base software, FORMWISE EXPORT systems provide a range of solutions, working in the user friendly Microsoft Windows 98 or later environments, for the management of the export department and the production of export documentation using standard Windows printers, to print both data and format on to plain paper, or graphics files (PDF or PNG) or to output files to transfer data in CSV or EDI formats. The most recently developed output file is XML format where both document image and data for direct input to suitably enabled business control software.

The Windows version of the software was written to take advantage of the capabilities of the Windows environment, in both single and multi-user variants, to meet a range of customer needs there are three versions of the software :-

**ELITE** is the basic module holding the elements of an export transactions, providing an inexpensive solution for the smaller

ELITE PLUS has a wide range of additional formats and reporting functions and can manage a transaction from quotation to invoice/consignment.

EXPORT is designed for the larger export function and also provides European Union Reporting and Commission Management and Labelling modules.

In short there is a **FORMWISE EXPORT** software system available to match the budgetary and power requirements of a range of users.



#### **FORMWISE ELITE**

is the base system contains databases for complete export transactions, which apart from all the names and addresses of parties such as consignees, forwarders/ carriers, banks, etc. also includes, amongst others :-

products additional charges shipping descriptions

The windows version of the software involved a total re-write and was actively extended in response to customer requests which therefore broadened the scope of the software to allow export traders to do purchasing and sales order processing an example being **Consolidated Tools International**.

Most of our customers however are running a sales order processing system, on a range of computer platforms, and have had their systems customised to extract and download such data as is available. This is then read and processed by **FORMWISE** so that any re-keying of the data is avoided and systems integrity is maintained.

A further significant inclusion in the software is the ability to create documents which can be attached to e-mails, thus making document delivery almost instantaneous and giving customer care a significant boost.

All versions of the software have the capability to output submissions to HM Customs & Excise New Export System, for the cost of an e-mail rather than pay the forwarder/carrier.

This transmission of "documents" has now been extended to the inclusion of the creation of XML files to the UN-eDocs UK standard. These "documents" not only allow a recipient to view and print the information, but also to import the data into his own business software and save re-keying and allow a seamless transfer of data.

We are SITPRO electronic forms licencees and use the latest SITPRO Topform pack as the basis of our forms, but as FORMWISE was designed to be adaptable to your requirements, we also produce bespoke forms, some of which, for example the defence contractors exit documents, are unaligned. Apart from a few statutory forms, the use of pre-printed forms, which can cause bottlenecks and wastage, is abolished as the form and data is printed at the same time, using standard Windows printer drivers.

The ability to get information to other parties quickly is of paramount importance, and as FORMWISE EXPORT in the Windows environment uses manufacturer's standard printer drivers thus allowing the use of a huge range of bubble-jet and laser printers. It is possible to send document by fax/modems. Possibly of greater impact is the ability to create compact graphics files, thus allowing a system of documents attached to e-mail messages no matter what the e-mail delivery system, such documents being available for viewing and printing by version 4, or better, standard internet browsers.

We assume responsibility for changes in regulatory procedures and issue advice through our telephone support line, quarterly newsletter and via our website. This ensures that Formwise §xport systems will be maintained to the latest standards at no extra charge for those customers contracted for annual maintenance.

#### LINKS TO SALES ORDER PROCESSING SYSTEMS—2

We really do believe that a user should continue to run their own business control package, and more and more of those packages have ODBC drivers which allow the extraction of data. If you are in a situation where there is no IT experience to produce the extract files, then we are in a position to help produce routines to do this.

The first batch of these are three extract files which can speed up the installation of Formwise :-

- An extract of Account holders Names and Addresses 1.
- An extract of Delivery Names and Addresses 2.
- An extract of the stock product descriptions, commodity code, weights, cubes etc

This populates a large part of the database and allows the expansion of delivery address default data, which will in turn speed up the production of documentation later in the cycle.

In a situation where :-

- the business control software does have ODBC drivers available
- 2. there is an installation of Microsoft Excel, or preferably Access
- there is the possibility of speaking to someone, either within your 3. organisation, or from your software supplier, who has a knowledge of the database tables

then we can offer a service of installing routines to extract the above data, on installation of the system.

The other extract is of despatch/invoice information to cut down the amount of re-keying of data and maintain systems integrity. This would install a routine which allows the user to input the despatch note or invoice number for which data is required, have the data extracted and routines within Formwise to read that data, so that no re-keying of numbers and dates, and product quantities, descriptions, commodity codes, and weights is required. Such that documentation processing is reduced to the minimum.

### DOCUMENTS BY PRINTER, FAX / MODEM OR E-MAIL

#### Printers:

The Formwise software uses your installed windows printer drivers, so that any printer capable of printing on A4 size paper with the necessary fonts can be used, indeed we have found a dot matrix printer capable of printing documents.

#### Facsimile:

Not so many years ago the only way to transmit documents was sending by mail or courier and then along came facsimile machines, and also, through a print driver, fax software to send documents direct from your desktop personal computer. The cost of transmission can be quite expensive, and with certain countries merely getting through is somewhat of a lottery.

#### E-mail attachments in PNG format:

With the speed and minimal cost of e-mail, more and more business is being conducted by this medium, and we have enhanced Formwise systems to create files which are documents for attachment to e-mail messages, these files are e-mail software and printer independent.

Sending e-mail messages ensures that the correct party receives the message, through notification if it does not arrive, and with the speed of e-mail there is an obvious improvement in customer service. Quite apart from that there are distinct cost benefits from using e-mail in that to send three pages attached to an e-mail message is likely to be transmitted in under a minute, AT LOCAL CALL RATES, whereas sending a 3 minute fax can be quite expensive.

It is extremely difficult to estimate how much of the total usage of a fax is for sending documents, but customers making use of this facility estimate savings in a range from £60 to £600 PER MONTH. There are other ways to make savings and one of our enterprising customers has set up an arrangement that these "documents" are e-mailed to a consular services company, who print them and then obtain certification and legalisation, and then courier them back with the consequent savings in cost and speeding up of delivery time.

Our standard e-mail documents, which can be attached to messages from your e-mail system, are in the PNG (Portable Network Graphic) format, and providing your trading partner is using a PC using either Windows 95 / 98 / NT / 2000) and either Internet Explorer 4 or Netscape Navigator 4, or better, will be able to view and print the attachments. If no browser is available, we can supply a small executable program which will provide those facilities. This will provide your customer a non-printer specific method of printing your documents as soon as he collects his e-mail.

### E-mail attachments in PDF format:

An alternative would be the use of a print driver which outputs Adobe Acrobat PDF files for which many users have the reader programme which is freely available on the web. Our preferred software is PDF Print Factory from Software-Partners, and there is a professional version of the driver (cost £60) which allows the attachment of passwords to protect the documents from being edited.

#### E-mail attachments in XML format:

A further alternative for transmission of documents is in the format of an XML file. The Formwise System is currently being updated to allow the creation of XML files in accordance with SITPRO's UN-eDocs-UK specification.

### DOCUMENTS BY PRINTER, FAX / MODEM OR E-MAIL

E-mail attachments in XML format: continued.....

An XML document has the capability of allowing the recipient to view the file through a suitably enabled software package (Word / Excel / Internet Explore). The "document" is translated on screen, but holds the data in a format which has the potential to be input into the recipient's business control software without re-keying. Obviously this would speed up the process of data input and has data integrity inbuilt between disparate packages. Currently Formwise will output the commercial and transport master documents.

However, the files do tend to be quite large, especially when compared with PNG and PDF file formats, and therefore the current thinking is a single file containing all data for a consignment will be constructed, and you may rest assured that Formwise will be modified to produce this single file in due course. In terms of customer service, we think a customer would be more than happy with this extension of customer service.

Speeding up the information flow by the use of e-mail means that your customer can pass these "documents" to the receiving warehouse, import agent etc., and thus within minutes of despatch, necessary parties are thoroughly advised of the transaction.

### H.M. CUSTOMS DOCUMENTS AS ELECTRONIC DATA

Obviously using electronic data messages, output from the system, to give information to other parties about a consignment is efficient from the exporter's point of view in that no rekeying of data is required and information can be passed quickly by electronic mail to the relevant parties. If the recipient of the message has access to systems which read that data, and allow further processing, then the efficiency savings are doubled.

A few years ago the use of electronic data interchanged (EDI) was seen by many as the ideal way to proceed, but take-up by all sectors of industry was very low because of the complexity and costs of implementation. However over the past few years with both the growth of software tools to take away some of the mystique and the growing familiarity of all levels of staff with electronic messaging, the staff time saving potential has become an irresistible force for change. In one specific area HM Customs have also made things much simpler to provide Intrastat and Sales Listing data and NES submissions by a range of options and thus save themselves having to enter that data for themselves.

The big plus is that it is now possible to send that data, without having to spend not inconsiderable sums to join specialist EDI communities, and merely use e-mail or the internet. This provided the impetus and we at Formwise developed the capability to output these electronic messages. The take-up has far out-stripped our expectations with most customers converting to electronic rather than paper reporting in a short time.

The implementation of the "New Export System" will further reduce data entry and the "paper chase" of C88's (SAD's). Thus HM Customs can use their staff more effectively in other target areas, eg smuggling and fraud detection.

We have modified Formwise to work via three routes:-

- Via the Bell Davis or CNS service for the implementation of NES. A ball-park figure for implementation is approximately £2000 start-up with running costs for a quantity of messages, and
- 2. to output the message direct from Formwise and use e-mail
- XML wrapper for submission via the government gateway for secure sending for RPA

We are have tested, as far as possible, to ensure that Formwise systems are capable of producing the relevant messages to ensure that the minimum of effort will be required to comply with the new system and obtain clearance quickly and effectively. The added benefit for CAP product exporters should be the use of one message to cover both HM Customs and CAP procedures.

The average charge from a forwarder/carrier for an NES submission would appear to be £15, which can be replaced by an e-mail or gateway upload of data extracted from the system, so a fast payback for the system cost is within reach.

Users now have the ability to output documents by printer, facsimile, or e-mail attachment, and to report data to HM Customs by electronic message.

## **E-Commerce and Formwise**

In co-operation with another software house, we have mapped out the possibility of creating a suite of programs to allow you to create an upload to a web-site, of products extracted from the Formwise files. There will also be the opportunity for your customers to complete orders and prospects to make enquiries on-line .

#### These are as follows:-

- 1. Output a CSV file of the products which can contain code, description, quantity, ex-works price etc., and when a field is added a link to a picture of the product.
- 2. Import that CSV file into say Microsoft Access or Excel to allow formatting for fonts etc.
- 3. Output a file from Access/Excel in the required format to upload and update the web-site.
- 4. Prospective customers would be able to log on to the site, and complete an enquiry or request for a quotation, whereas
- 5. Given the maintenance of passwords etc for customers, a customer would log on to place an order
- 6. In either of the two scenarios above, the web-site would generate an email advising of the placement of an enquiry or order.
- 7. The site manager can then log on to the site, extract the necessary data
- 8. The extract can then be read the file into Formwise, which will allocate the next order reference as the consignment key and create products only for those items which the customer has specified quantities.
- 9. The enquiry / order can then be handled through Formwise in the normal way, but without the need for data to be re-keyed.

- C. Ensure accuracy as you will be working with the prospect/ customer data
- D. Ensure that enquiries / orders are never overlooked
